## Forex-Trading Review

### Program Description

Forex-Trading (<http://forex-trading.ath.cx/> ) is a small brokerage company which offers several investment plans secured by daily trading on Forex. The company honestly warns its clients about the possibility of losses as this kind of business activity involves certain levels of risk. However, the company places great importance upon successful risk-management strategies to eliminate this possibility. The daily trading statistics is published on the website on a regular basis to keep the investors updated on any of the recent progress. The company's specialists practice a transparent business policy demonstrating their willingness to share skills and knowledge required for successful trading on Forex in the "Trading Academy" section of the website.

### Business Concept

The program offers several regular investment plans, a profit plan, and special managed Forex accounts. The deposit range for the regular plans is US \$20-10000, with a daily profit of 0.4-0.7% per day. A 5% deposit fee is applicable at no withdrawal fees being charged for this option. The minimal investment for the program's profit plan is US \$250 (with the maximum being currently fixed at US \$20,000). This option offers a special managed Trader's Account with 10% risk of the total account balance. The trading results for this plan are independent from the regular plans. A 10% fee is applicable every time the money is transferred, with a 90% profit/loss sharing of the Forex trading results. Finally, the special managed Forex account option, with the investment range of US \$1000-10000, offers a conservative trading strategy with the same 90% profit/loss sharing but a lower withdrawal fee (2%). The daily trading results for this plan are available in the "VIP Lounge" section of the company's website. The program is also offering a 5% referral bonus under the regular investment plans only.

The interest is paid to internal accounts on a weekly basis with US \$10 being set as a minimal withdrawal amount. The company accepts deposits either via E-gold or wire transfers. In case with E-gold, the deposited amount appears on the account balance instantly. The processing time for withdrawals is between a few hour and ten working days, depending on the amount of money being withdrawn.

## Website and Customer Support

Forex-Trading is using a dynamic CX domain to prevent the possibility of DDOS attacks. In case this type of an attack ever occurs, the company's database is completely secure and the website will be restored within a few hours. Another security feature implemented on the program's website is a PIN-protection system, similar to the one of E-gold: every time you attempt to enter your internal account a PIN code is sent to your e-mail address in order to prevent unauthorized access. If the PIN code doesn't arrive on time, allow a few minutes for the message to appear in your mailbox.

Forex-Trading offers an extensive customer support via their contact form, bilingual forum (English and German), and Skype (free online phone call service). A newsletter with most recent updates is also issued on a permanent basis.

## Our Opinion

The program is not heavily advertised on the Internet and has never been. This fact indicates its independence from the influx of new funds, proving the company's actual involvement on the global currency market. Furthermore, the administration of Forex-Trading has announced the upcoming closure of the program to new members. Hence, we view Forex-trading as one of the best investment options currently available on the Internet.
